



Community Treebate Program 2027 Spring & Fall Planting

- This program covers the cost of trees and shrubs **ONLY**.
- Residents/households within the WIWD boundaries are eligible to apply. Contact the WIWD to ensure you are within the boundaries.
- Rebate forms will only be accepted with an accompanying copy of an **ITEMIZED RECEIPT & PICTURES** that prove planting of the purchased tree(s).
- All trees/shrubs must be planted within the WIWD boundaries to qualify for rebate.
- Please refer to the **WIWD Invasive Species List** when purchasing trees/shrubs. Invasive Species are **not** eligible for this program.
- Once all requirements are reached and application is submitted, the WIWD will issue a cheque (**maximum \$80.00**) rebate to successful applicants.
- One rebate per resident/household per year. Businesses are not eligible to apply.
- Programming is based on a first-come, first-serve basis.

STEP 1: Order your trees from any supplier any time after **September 1st, 2026**.

- Ensure variety is suited for your area (WIWD boundary area is plant hardiness zone 3)

STEP 2: Wait for your trees to arrive. (April 1 - Oct. 31, 2027)

STEP 3: Plant your trees in the spring or fall of 2027 (and take pictures!)

STEP 4: Fill out the Community Treebate Form.

STEP 5: Submit the **1.TREEBATE FORM**, **2.ITEMIZED RECEIPT** and **3.PICTURES** of the planted trees to the WIWD office via mail, email or in-person between **April 1st, 2027 – October 31st, 2027**.

Terms & Conditions

- Rebate cheques will be issued for eligible trees and shrubs **ONLY**
- Trees and shrubs must be ordered anytime **after September 1st, 2026**.
- Planting location must be within the WIWD boundaries to qualify for rebate.
- Submit completed rebate form, itemized receipt, & photos of the planted trees/shrubs.
- Maximum rebate: **\$80.00** per household, covering product cost, GST & PST. (Shipping not included).
- Limit of one (1) rebate application per household/resident per year. (Businesses are not eligible.)
- Rebates are issued by cheque; ensure accurate mailing address is provided.
- Rebates to be distributed on a first come first serve basis. Program is subject to available funds, and may be discontinued without notice.

***Please note that planting trees during July and August is not recommended, as high temperatures can increase stress on newly planted trees/shrubs.**
